Accounting Policies and Notes forming part of Accounts- FCRA
for the year ended 31st March, 2014

A. Significant Accounting Policies

1. Basis of Preparation

The financial statements have been prepared on historical cost basis following the cash basis of accounting, unless otherwise stated, the generally accepted accounting principles and the accounting standards to the extent applicable, issued by the Institute of Chartered Accountants of India.

2. Revenue Recognition

- a) General Donations are recognized as income on actual receipt basis.
- b) Donation received specifically for corpus is being reflected under that head.
- c) Interest earned on fixed deposits is recognized as per TDS Certificates issued by the respective bankers.
- d) Interest and other income received in specific funds are directly credited to respective funds, without routing the same through the Income & Expenditure Account.
- e) Grants from various funding agencies are recognized as Income to the extent utilized to meet the project expenditure and transferred to Statement of Income & Expenditure and balance amounts shown as "Unutilized Grants" in the Balance Sheet. Similarly, amount overspent in few cases in a particular year / expenses incurred pending receipt of grant amounts (though sanctioned) are shown as "Grants Receivable" at the year end.

3. Project Expenditure

Proportionate expenditure including salary cost has been paid through various projects funded by International Agencies and other Agencies on a basis considered reasonable by the Management.

4. Fixed Assets / Fixed Asset Fund

- a) Fixed assets acquired during the year are being charged off to Income & Expenditure Account. However for ensuring financial and physical control, fixed assets are being shown in the Balance Sheet at their depreciated value with a corresponding amount in the Asset Fund.
- b) Depreciation on Fixed assets is provided on Written Down Value at the rates and in the manner specified in the Income Tax Act, 1961.

5. Foreign Currency Transactions

Grants / Donations received in Foreign Currency from "Foreign sources" are directly credited to FCRA Bank Account and recognized at the exchange rate prevalent on the date of receipt.

6. Investments

Investments mainly comprise fixed deposits with banks which are valued at cost.



B. Notes to the Accounts

1. The society is registered under Foreign Contribution (Regulation) Act, 1976 bearing registration no. **231650137**.
2. Previous year figures have been regrouped / reclassified, wherever necessary, to make them comparable with the current year figures.
